MEDICAL DEPARTMENT.

The Contractor for Schedules Nos. 7 and 8 will be required to deliver the supplies for the Victoria Hospital for Women and Children at the Hospital on Barker Road (Peak).

The Contractor for Schedule No. 8 will be required to supply store accommodation, ample enough for the housing of provisions, and such store must be kept in a sanitary condition.

The Contractor for Schedule No. 10 will be required to collect the bedding and clothing at the Civil Hospital and Victoria Hospital for Women and Children on Barker Road (Peak), returning the same to these institutions when washed.

Except where otherwise stated, the Contractor will be required to deliver all supplies at the Civil Hospital.

The Contractor will be required to deliver all supplies, etc., free from any additional charge, beyond that stated in his tender.

The Government does not bind itself to accept the lowest or any tender.
