SPECIAL CONDITIONS.

1. The Purchaser of either Lot shall not have or be entitled to any right of access to the sea, or to any right of access to any water which may be near to the said Lots or on which the same abuts, or to any compensation whatever in the event of any reclamation being made between any part of the said Lots and such sea or water; and a special proviso to this effect shall be inserted in the Crown Leases of the Lots.

2.
